Subject – Report on vandalism, looting and burning of properties.

Sir/Madam,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Qtr. No. 2/III -H, Lamphelpat, Imphal West, Manipur. That, on the 16<sup>th</sup> June 2023 at 5:30 Pm my above said residence (owned/rented) was attacked, destroyed and looted every valuable properties from my owned/rented house and premises worth Rs. 26,20,000/- (Rupees Twenty six lakhs and Twenty thousand only) (approx.) and they burnt down all remaining things.

That, while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like "HAO HATLO, KUKI HATLO" "KANGLEIPAK YAI PHARE" etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering at FIR/Zero FIR under relevant sections of our country. The cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
