I, the undersigned Mr. Hauzel Thlungliana S/o (L) Hauzel Hangtual aged about 67 years, Having Permanent resident at Salem veng Churachandpur District, Manipur-795128 would like to bring to your kind attention the incidence of crime perpetrated at my residence located at Laimanai, Meitei Langol, Opposite Trevi Hospital, P.O. & P.S Lamphel, Imphal West District, Manipur-795004

The specifics of incident are as follows:

- 1. Place of incident: Residence of Mr. Hauzel Thlungliana located at Laimanai, Meitei Langol, Opposite Trevi Hospital, P.O. & P.S Lamphel, Imphal West District, Manipur-795004 2. <u>Time of Incident:</u> 28<sup>th</sup> February, 2024 at around 2pm

Brief history of the incident: On the day of May 3<sup>rd</sup> 2023 the ethnic cleansing perpetrated by armed radical groups Arambai Tangol and Meitei Leepun was at full force. Many lost their lives and many are subjected to hard conditions. Fortunately we were able to escape the onslaught as we quickly headed for safety to Lamphel CRPF Camp. Then on 7th June, 2023 at around 2:30 the radical Meitei groups looted all my properties and burnt my house causing me considerable hardship and mental anguish. To add to my misfortune there was a report on February 28, 2024 that my resident at Laimanai, Meitei Langol, P.O. & P.S Lamphel, Imphal West District, Manipur-795004, was occupied by Metetei Terrorist group known as UNLF and was used as their base of operation. It's shocking to hear such news of a Terrorist organization, armed with state of the art weaponry was given free reign by State police forces and the Central forces.

In light of this I would like to reiterate the Supreme Court order passed on 25th September, 2023 directing the state government to ensure protection of the properties of displaced persons, as well as those which have been destroyed or burnt in the violence, and to prevent the encroachment of such properties. In compliance with the Apex court order the Government of Manipur issued an order vide. Order No. H-3608/2/2023-HD-HD dated 10<sup>th</sup> October 2023, stating that State government views the matter very seriously with utmost sensitivity and that the respective Deputy Commissioner

Therefore, In accordance with the State Government order, I earnestly request you to drive out the llegal occupants and take appropriate stringent action against the perpetrators by registering a ZERO FIR under relevant sections of India Penal Code (IPC).
