With due respect, I the undersigned have the honour to report that some unknown miscreants suspected to be from the Meitei community has looted and destroyed my house which was built for rented purpose located at Khongsai Veng, Laipham Khunou, Imphal East, Imphal.

They have looted and destroyed the said building during these current volatile situations in between 3rd May 2023 and 18th of December 2023. I am unable to produce the exact date of the incident as I was already displaced from the location since the 3rd of May 2023. However some friends informed me about the condition of my house along with a video clip on the 18th of December 2023 from where I established the fact about the destruction of my house.

The approximate value of my house including the pucca fencing walls, gate, garages and other infrastructures may be about Rs.50,00000/- (Fifty Lakhs) only.

I therefore request you to kindly take up necessary actions and to book the culprit as per the law of the land.
