I am unable to produce the exact date of the incident as I was already displaced from the location since the 3rd of May 2023. However some friends informed me about the condition of my Quarter on the 18th of December 2023 from where I established the fact about the loss of my property.

The approximate value of my property that has been looted may be around Rs.50,00000/- (Fifty Lakhs) only.

I therefore request you to kindly take up necessary actions and to book the culprit as per the law of the land.
