I have the honour to state that today i.e. 10/05/2024 at about 08:00 am on receipt of reliable ation from Tamenalana B. ... information from Tamenglong Battalion AR and further corroborated from our own sources about the movement of some significant in the movement of some significant in the movement of some significant in the significant in th the movement of some active cadres of MNRF (Manipur Naga Revolutionary Front) organisation in and around Lancel Communication of and around Langol Game Village area with a view to commit prejudicial activities like extortion of money from the control of t money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei and we to commit prejudicial activities that the commit preju Achouba Meetei and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW conducted frisking and checking at Mary Kom road near Oinam Traditional Healing Centre. During that, one Hyundai Santro car white in colour bearing registration number MN04A 6138 coming towards our frisking zone from Game Village side was stopped for spot checking and verification. On spot checking the vehicle one person who was driving the vehicle and who later identified himself as K. Gaijailung (41 yrs) S/o. (L) K. Khanglubon of Longmai, Noney-1, was found frightened on seen the security personnel. Due to his suspicious nature he was detained at the spot for further verification. On spot body search one black side bag, one wallet brown in colour containing a sum of Rs. 320/- (Rupees three hundred and twenty only) and one Aadhaar card recorded in his name and 2 (two) mobile handsets i.e. (i) one Galaxy A05 mobile handset (IMEI No. 350835033885778/01 and 351072883885778/01) along with 2(two) SIM cards :- (a) one JIO SIM card bearing phone no. 9366331127 (as disclosed by him) and (b) one Airtel SIM card bearing phone no. 8729932030 (as disclosed by him) and (ii) one itel ACE mobile handset (IMEI No. 356293349924721 and 356293349924739) without any SIM card were recovered from his possession.

On further verification he disclosed that he is an active member of MNRF organisation and started working for the said organisation since January, 2024 through one M. Maring, General Secretary of MNRF organisation. He further disclosed that, in the month of February, 2024 he, under the instruction M. Maring, had served demand notes of the said organisation to ABCI Company located at Awangkhul and Rahee Company located at Noney. He also disclosed that, in the first week of May, 2024 he had collected a sum of Rs. 5,00,000/- (Rupees five lakhs only) from the companies located at Noney side and handed over the collected money to one unknown person send by M. Maring for their party activities. Hence, he was arrested at the spot at 11:10 am and seized the above mentioned recovered items along with the Hyundai Santro car white in colour bearing registration number MN04A 6138 at 11:20 am from his possession.

Hence, the arrested person along with the seized items are handed over to you for taking further necessary legal action against him.
