Sir,

I have the honour to report that due to communal violence in between Kukis and Meiteis on the 4th May, 2023 at around 3:00 pm some unknown miscreants suspected to be Meitei communities Arambai Tenggol, Meitei Leepun and Local Meitei people forcefully attacked my residential house located at Khongsai Veng Laipham Khunnou, Imphal East District.

As a result, they destroyed and looted all my household properties including all important documents and later burnt down my house. The loss properties are approximately worth as Rs. 90(Ninety) Lakhs only. Due to displace of all my family, I could not report in time.

I, therefore, humbly request you to kindly take up necessary legal action as per law of the land.
