Subject: Complain Report

Sir,

I am to state that on 3<sup>rd</sup> May, 2023 at about 9:00pm our locality Meetei Langol National Games Village under Lamphel Station (Imphal West) was under Mob attacked by thousands of unknown miscreants belonging to Meetei Community suspected to be Arambai Tenggol, Meetei Leepun, Kangleipak Kanba Lup with criminal intention to cause damage of properties and life. On 4<sup>th</sup> May, 2023 at 7:00am. For our safety, we were escorted by CRPF personal to their camp (CRPF Camp) at Lamphel.

From there we have seen many houses were burning and destroyed but I was not assured that my house amongst those burnt and destroyed. As such, I could not make a complaint to the Police FIR. However as per information received from reliable source on 19/12/2023 my house (building) which was under construction at Meetei Langol, National Games Village zone-I Phainom Colony Imphal West Manipur dismantled and vandalized my house which is under construction and looted all my materials for construction of my house without leaving behind.

The approximate total loss of my properties item worth is Rs. 60 Lakhs (Sixty Lakhs) only.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.
