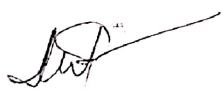

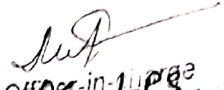

Sir,

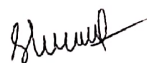
With utmost respect and regards, I have the honour to
state that on 3rd May, 2023 at around 20:00 hours
unknown miscreants numbering more than 1000 suspected to be
volunteers of mkei world council, Arambai Tengol, Kangkepok Kanka
Lup. Meetei Leepun attacked ~~Lakhongsa~~ Veng and vandalised
my private residence house and looted all my house-hold
properties including my private scooter vehicle (Activa) B/R no.
MN01AF1554.

The total cost of my properties worth Rs. 57 lakhs (approximately)
I, therefore kindly request you to lodge FIR in connection with
the incident.

The reason behind for late information is, due to certain health
issue and out of station, on May 7th we had moved to Kolkata via
Guwahati for treatment and returned to Kangpokpi on 30/11/23.
The above details is the reason for late FIR.
