I have the honour to report that, due to violence erupted on 3<sup>rd</sup> May, 2023, we the Kuki community could not re-settle at Imphal Valley. So now, I, along with the family members are displaced to Kangpokpi Mandap Relief camp, Kangpokpi District.

It is learnt that, my residential house bearing patta no. 91/2412 at Gamngai Veng, Phaippijang, Langol, P.O. Lamphelpat, under Lamphel Police Station, Imphal West District, Manipur was completely burnt down by Meitei miscreants on 9<sup>th</sup> August 2023 at around 6:30 pm.
