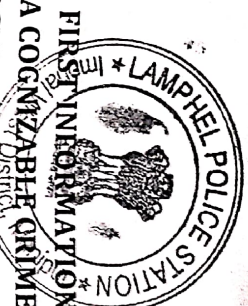

I have the honour to report to your
Honoured Officer that on the fateful night of 3rd
May unknown miscreant and Arsonist of Meitei
Community belonging to Anambai Tengol and
Meitei Leepul Group with the help of locality
persons set houses, churches & business establish-
ments on fire belonging to Chen-Kuki-Mizo
Community in Langol and adjoining areas where
I am resident.

On the subsequent days that followed they
burn many more houses residential homes and
engaged in daylight robbery and theft and
destroying whatever is left that they couldn't carry

In the fear of my life and my family we
fled from our home leaving behind my house
and all the property. I no longer feel safe
and my life has been in ruins which is a far
cry from recovery. In addition to my hard
earned materialistic property in the course of
decades in mental trauma suffered by our family
and all others of the Chen-Kuki-Mizo community
can never be justified.

I therefore urged your department to identify
and take appropriate action as per law against
any groups and individuals involved.
