Subject: Report on crimes of vandalism & looting of properties Discrimination of
Schedule Tribes.

Sir/Madam,

With due respect, I beg to state that, I am a Schedule Tribe belonging to the Hmar Tribe which is a recognized tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

And with reference to the subject quoted above, I am to bring to your notice that on the 18th April, 2024 at around 10:00 AM, my house which is under construction nearing to completion at Spring Villa under 91 - Meitei Langol, Imphal West was vandalized and the building materials looted by a group of unknown miscreants, as well as unused building materials. All this occurred as soon as the Central Security Forces were withdrawn from Langol Area by the Govt. The cost of construction is approximately around Rs.50.50 Lakhs including materials.

A copy of approximate cost of the said building and Jamabandi are enclosed herewith.

Therefore, with utmost respect, I request you to take appropriate actions against the perpetrator by registering ZERO FIR under the relevant sections of the Indian Penal Code.
