All this occurred as soon as the Central Security Forces were withdrawn from Langol Area by the Govt. The cost of construction is approximately around Rs.50.50 Lakhs

Therefore, with utmost respect, I request you to take appropriate actions against the perpetrator by registering ZERO FIR under the relevant sections of the Indian Penal Code.
