I am to report that on 4th May, 2023 at around 4:00 PM in the evening some unknown miscreants have forcibly entered at the Quarter no. Type-II, D-29, PWD Quarter, Lamphel, Sanakeithel, Imphal West occupied by my brother Thanglun Minthang Gangte Hav. No. 072011008 of 7th Bn. Manipur Rifle Khabesoi, by breaking the lock of the gate and main door, while I along with my family were taking shelter at 86th Bn. CRPF Lamphelpat, Imphal West, due to the current ongoing ethnic clashes. I would like to mention that my family and I were residing with my brother's family for a short period of time during the ethnic clashes.

Apart from looting all my household properties and furniture/personal belongings, the following items issued to me by the department of Postal Services, Jiribam were also looted by the

2. IPPB MOBILE(SAMSUNG) in which a sim card bearing mobile number +917303308974 was also looted. Unfortunately, we did not keep a record of the IMEI number and since the mobile number along with the mobile is lost, we could not secure the IMEI number to produce it before you.

I would also like to extend my deepest apology for the delayed report since we had to migrate from one state to another as we did not get a direct flight ticket to our desired destination at an earlier date. Hence, I begged your consideration in this regard on humanitarian ground keeping in mind the physical, mental and psychological trauma we had endured being an Internally displaced

In view of the above report, you are therefore, requested to kindly take swift action to bring these criminals to justice so as to recover my lost properties at an early date.
