**Subject:** Request for filing a complaint (Zero-FIR) in c/w recent attack against me.

Sir,

With due respect, I would like to report a cognizable offence carried out against me and my niece on 4<sup>th</sup> May 2023 around 09:00 AM wherein a large gathering mob of meitei community conspired and instigated by Meitei Leepun & Arambai Tenggol of valley based CSOs attacked on our Quarter Campus (CPWD Quarters, Sanagiprou, Imphal), looted/destroyed/vandalized our premises rendering me in a state of homelessness. Fearing loss of lives and being in a state of vulnerability, I along with my niece had fled and now taken refuge and shelter at Hiangtam, Lamka, Churachandpur.

That, the assets/properties and damages were estimated at Rs. 4,63,000.00 (Four Lakhs Sixty Three Thousand Only).

There was a delay in filing of FIR as I have not fully recovered from the trauma suffered because of the incident, my personal health issues (cancer) which has taken much of my time, and a general unawareness of the legal implications surrounding the entire incident.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abettors for their heinous acts carried out against me.
