Sub :- Request for necessary actions against one Seram Ramchandra Meitei (Self-styled president of Popular Pisciculture Association, Manipur), aged about 65 years, S/o Late Seram Nilachandra Meitei, a resident of Sagolband Sayang Road Konthoujam Leikai, P.O. & P.S. Lamphel, Imphal West District, Manipur for his many illegal acts/activities.

Sir,

I, the undersigned, have the honour to submit the following few lines for your kind perusal and necessary action(s) pleased.

1. That, I am lodging the present written complaint against the above mentioned Seram Ramchandra Meitei who is now acting as a self-styled President of the Popular Pisciculture Association, Manipur and he alongwith some other unknown persons have been occupying the office premises of the said Association illegally and forcibly for their personal vested interest.
2. That, the said Seram Ramchandra Meitei alongwith some other unknown persons have been threatening and harassing me and my family in many occasions by sending threatened messages through mobile phone as well as keeping explosive bombs and bullets at my gate in which the concerned police station has also registered suo-motu FIR Cases bearing FIR No.1(01)2024 I-PS US 307/506 IPC and 4 Expl. Subs. Act and GD No.15 I-PS dated 26.11.2022.
3. That, even I have changed my previous senior advocate/counsel namely, N. Jotendro Singh as threatened by some unknown persons for withdrawal of the cases/matters and not to contest the case(s) in connection with the Popular Pisciculture Association, Manipur, pending before the Hon'ble High Court of Manipur and its subordinate courts. In the similar lines, I have already made complaint to your esteemed office and the concerned authority(ies).
4. That, it is learnt that the said Seram Ramchandra Meitei has made a written complaint to the Chairman Peoples' Tribunal Committee, UNLF, Manipur (Underground outfit organization) dated 26.03.24 Kangla with many false allegations and concocted story against me. The said Seram Ramchandra Meitei is not the President of the Association but he is still impersonated and misguided/misled many other in collusion with some other unknown persons. 
