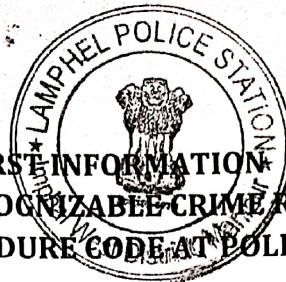

I have the honour to report that I was staying in the residential house of one of my relatives at Khongsai Veng, Laipham Khunou, Imphal East. That on 4th May, 2023, we had suddenly left our residential house due to the attack of Meitei mobs, we fled away for the safety of our life. So, my vehicle, two wheelers Java Forty Two Duals Chabs b/regn. no. MN01AL-7468; chassis no. MZDKW1C16N1A79344, Engine no. NEE-NA019905; Matt black in colour was left unattended and later I came to learnt that the said vehicle was stolen by the unknown Meitei mobs. However, the exact date and time of the loss of my vehicle could not be ascertained.

It is therefore, requested to kindly take a legal action as per the law. Due to unavailability of proper places for accommodation and other necessary requirements, I could not stay in a confine place and thus the report has become delay.
