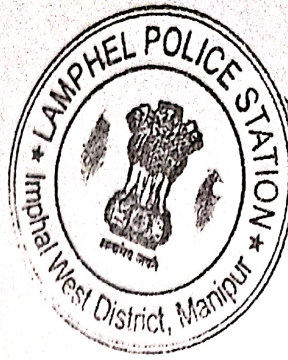

Subject: - Enquiry report.

Sir,

As endorsed, I have conducted an enquiry regarding the complaint report lodge by Nepram Romeo Singh S/o (L) N. Lokeshwor Singh of Sagolband Nepra Menjor Leikai. During the course of enquiry, I have visited the P.O and examined the staff of Maion Greentech Pvt. Ltd. located at Sangaiprou Ningthemkol Leikai, Imphal West, who were present at the time of incident. Mr. Phurailakpam Gyaneshwor Sharma (42) yrs S/o Ph. Nabakumar Sharma of Sagolband Bijoy Govinda Mamang Leikai who is the Sr. Office Assistant of the company stated that on 20<sup>th</sup> March at around 10:40 am, two persons entered their Office and ask them to meet their Managing Director. To this Query, he told the unknown person that their Managing Director is out of station. few minutes later, around 4 persons with their Arms enter again inside the office and threaten them by facing dire consequences of their life and properties if the Managing Director did not respond their calls. On checking the CCTV footage, it is seen some unknown persons wearing combat dress with Arms in their hand enter their office and checked their Almirah. The CCTV footage is seized from the position of Phurailakpam Gyaneshwor Sharma by preparing a seizure memo in presence of witnesses. It is stated that those unknown persons have forcibly taken away Money receipt Book (around 10 Nos.) stock receipt register (one) and School Documents (3 files) from the office. In view of the above facts, it is clear that some unknown persons with arms have entered the said office and threatened the staff to face dire consequences. Hence it is highly required to investigate the incident by registering a regular FIR under appropriate section of law. It is therefore submitted my enquiry report along with statement of the complaint and the staffs and the seized CCTV footage for further necessary legal action.
