Subject: Complaint report

Sir,

That, on 18-05-2024 at about 1:00 pm Shri Sinam Gokul Singh and Shri Ibohal Singh of Thangmeiband Sinam Leikai and his men threatened my husband Shri Anil Rai S/o Jagadish Rai to vacate our present home located at Manipur Pony Grazing Ground, Lamphelpat, Imphal immediately, otherwise he will face dire consequence. Thereafter, on 19-05-2024 at about 7:00 pm, some unknown persons who are the associates of Shri Gokul and Ibohal had came to my house and assaulted my husband with bamboo stick and leather belt. As a result of which my husband received severed injuries on his person and evacuated to RIMS hospital for medical treatment. Now he is admitted at Surgery Ward Regional Institute of Medical Sciences (RIMS).

In this connection, you are therefore, requested to take action against Shri Gokul and Ibohal and also his associates according to law of the Land.
