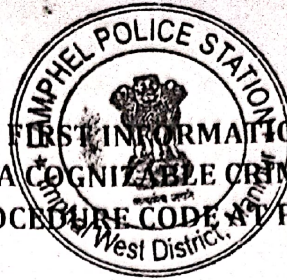

Sub :- Complaint of Vandalism and Assault Incident on 23rd May, 2024
damaging of properties of RIMS and assault of one Security personnel.

Sir,

Most respectfully, I have the honour to lay the few words for complaining of an incident occurred on 23rd May 2024 damaging of properties of RIMS, Imphal and assaulting of one of our RIMS Security Guard named W. Debendro Singh (58), s/o W. Chaoba Singh, Uripok Achom Leikai, Imphal West District.

2. That on 23rd May, 2024 at around 9.25 am, a group of ladies approached and vandalised the properties of RIMS, Imphal including RIMS- Barracket, poster and chair. They began to beat our security personnel by a stick who was on duty at the North eastern gate of RIMS, Imphal near SIB office. They damaged properties of RIMS on both sides of MTDC Gate and SIB Gate which were entirely unjustified and physical harm. This unprovoked attack was both alarming and distressing.

3. I request you to kindly register a criminal case against the accused persons involved in the incident.

4. I am enclosing with this letter the copies of medical reports, photographs and videos, the broken goods and other relevant evidence etc. I appreciate your prompt attention to this serious matter and look forward to your response.
