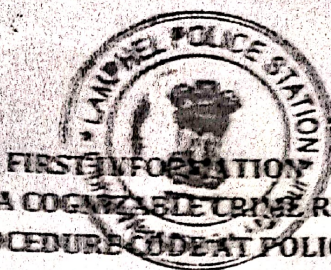



With due regards, I the undersigned have the honour to state few lines for your kind consideration and needful action.



Therefore, I request you to kindly take necessary action to trace out my stolen vehicle. Thanking you sir for your kind co-operation.


