Subject: Request for registering an FIR against erring officials on account of issuing forged land documents.

Sir,

In inviting a reference to the subject mentioned above, I have the honour to state that Shri Huidrom Ibohal Singh, of Lilong Chajing Karam, is currently serving as i/c AS&SO-XII in this directorate and has been assigned to carry out re-survey of 2 (two) revenue villages namely 60-Laijing Khullen & 68-Hiyanglam (copy of work allocation order enclosed)

It is reported from concerned AS&SO-I and AS&SO-VIII of this directorate that Huidrom Ibohal Singh has been issuing forged land documents in revenue villages which are beyond his assigned jurisdiction i.e. in 67/A-Khoidum Lamjao & 2/A Kharungpat revenue villages. The said land documents are being used in pursuing bank loans in various banks including SBI, Kakching Branch.

21 nos. of such forged land documents in 2/A Kharungpat revenue village and 8 nos of forged documents in 67/A-Khoidum Lamjao revenue village issued by Huidrom Ibohal Singh are enclosed.

Further, it can be observed in the above forged documents, signature of Huidrom Ibohal Singh, as AS&SO-XII & as Supervisor Kanungo alongwith signature of L. Ibomcha Singh (of Khongman Mangjil), as Mandol (copier).

Therefore, it is requested kindly to register an FIR against above mentioned erring officials on account of issuing forged land documents.






Accordingly, the forged documents were collected from Sub-Registrar Office, Kakching (21 copies enclosed).


