Today i.e. 18/6/2024 at 9:10 pm, received an information from MIKE-30, SP-IW Control Room that on the same day at about 8:50 pm, one Honda Activa (White in colour) bearing registration No. MN01AJ-3820, ridden by an unknown rider along with pillion rider coming from Malom side towards Imphal dashed by one four-wheeler Kia Sonet (Red in colour) bearing registration No. Nil, driven by an unknown driver coming on the same direction at Kwakeithel bazar near traffic point, due to rash and negligent driving on the part of the driver of Kia Sonet. As a result of which, the rider and pillion rider of Honda Activa received severe injury on their person and were evacuated to ASIAN Hospital for medical treatment in which one person was succumb due to his injury. Both the vehicles were badly damage.

Hence, a Suo-Moto case under FIR No. 399(6)2024 LPS u/s 279/338/427/304-A-IPC has been registered for investigation.
