I have the honour to state that today i.e. 22/06/2024 at about 06:00 pm on receipt of reliable information from 32 AR and further corroborated from our own sources about the presence of some active cadres of KCP organisation in and around Changangei Ucheckon area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking at Changangei Ucheckon, Tiddim Road near the approach road leading to Herbert School. While conducting frisking and checking one Mahindra XUV 500 white in colour without registration number coming from Airport side towards our frisking zone was stopped for spot checking and verification. On checking the vehicle one person (driver) who later identified himself as Akoijam Robinson Singh (31 yrs) S/o. Ak. Deban Singh of Leishangthem Khong Manung Makha Leikai, Thoubal District and 2 (two) occupants who later identified as Phijam Tomba Singh (50 yrs) @ Meiraba S/o. (L) Ph. Kokchao Singh of Sekta Mayai Leikai, Imphal East District and Lourembam Sadananda Singh (18 yrs) S/o. L. Shyamchandra Singh of Moidangpok Khunou, Imphal West District were found. On spot checking the following articles: (i) one Redmi 12C mobile handset along with 2(two) Airtel SIM cards bearing mobile numbers 7629037295 and 8974448636 (as disclosed by him), one brown wallet containing a sum of Rs. 1020/- (Rupees one thousand and twenty only) and one Aadhaar card were recovered from the possession of Akoijam Robinson Singh (ii) one Vivo mobile handset model no. V2029 along with 1 (one) Airtel SIM card bearing mobile number 8974174456 (as disclosed by him) and one wallet black in colour containing one Aadhaar were recovered from the possession of Phijam Tomba Singh and (iii) one Redmi 7A mobile handset along with 2 (two) SIM cards i.e., (a) 1 (one) Airtel SIM card bearing mobile number 7629031837 and (b) 1 (one) JIO SIM card bearing mobile number 9366920382 (as disclosed by him) was recovered from the possession of Lourembam Sadananda Singh.

On preliminary verification Phijam Tomba Singh @ Meiraba disclosed that he is an active cadre of KCP (City Meitei) organisation presently working under the command of one Paikhomba, s/s Chairman of KCP (City Meitei) organisation. He further disclosed that he joined the KCP (City Meitei) organisation in the year 2010 and was allotted Army No. 101204 presently holding the rank of s/s private. He also disclosed that he along with his associates namely Akoijam Robinson Singh and Lourembam Sadananda Singh were involved in serving monetary demand to the general public, business establishments etc. in and around Imphal area and the above mentioned recovered Mahindra XUV 500 was also used in their party activities. On preliminary verification of Akoijam Robinson Singh and Lourembam Sadananda Singh, they disclosed that they are active members of KCP (City Meitei) organisation and stated the same statement regarding their party activities given by Phijam Tomba Singh @ Meiraba. Therefore, Phijam Tomba Singh @ Meiraba, Akoijam Robinson Singh and Lourembam Sadananda Singh were arrested at the spot at 07:00 pm, 07:10 pm and 07:20 pm respectively and seized the above mentioned recovered articles along with above mentioned Mahindra XUV 500 along with its key from their possessions at the spot at 07:05 pm, 07:15 pm and 07:25 pm respectively by observing formalities.

Hence, the arrested persons along with the seized items are handed over to you for taking further necessary legal action against them.
