Sir,

With due regard and respect, I the undersigned have the honour to state few lines for your kind consideration and needful.

That on 27/6/2024 at about 7.55 pm, while my father namely Loktongbam Sunil Meetei, 53yrs was returning home from Lamsang side towards Uripok on his Honda Activa Scooter bearing registration no. MN01AE-2688 along with his friend namely Saikhom Ingocha of Lalambung Makhong Takhellambam. Suddenly, one Tata Motor company vehicle which is suspected to DI-Tata or Tata Magic driven by an unknown driver carrying drinking water pakages had dashed my father Honda Activa at Iroishemba Lane no. 5 area near Petrol Pump along UK road and fled away, due to rash and negligent driving on the part of the unknown driver of the said Tata vehicle. As a result of which my father received severed injury on his head and his friend also injured at his right leg and face. Thereafter, they were evacuated to RIMS Hospital for medical treatment and later my father was refer to Raj Medicity, North AOC for further medical treatment.

Therefore, I request you to kindly take necessary action against the said driver of the Tata vehicle. Thanking you for your kind co-operation.
