I am to report the recovery and subsequent submission of cache of weapons, ammunitions and explosive as a part of an operations conducted by a joint team of 16<sup>th</sup> and 18<sup>th</sup> Assam Rifles in accordance with the specific input received on July 5<sup>th</sup> 2024 at around 19:00 Hrs hills range at Wakan Village (RM 4708) approximately about 18 Km South West From Saikul-PS, under Saikul Sub - Division Kangpokpi District Manipur.

On the aforementioned date specific input was shared by intelligent agency regarding a presence of cache of weapons, ammunitions and explosives in the general area of near hills range at A Wakan Village. In response to the information, a column of one Officer, one JCO and fifteen others ranks of 16<sup>th</sup> Assam Rifles and one Officer, one JCO and fifteen others ranks of 18<sup>th</sup> Assam Rifles launched a search operation on 6<sup>th</sup> July 2024 at 0430 hrs in gen area of hill range at WakanVillage. At around 0648 hrs a suspicious patch covered with follage was found. The team removed the follage using a long stick and found cache of weapons and ammunitions.
