



Sir,

I have the honour to report that, today i.e. 06/06/2024 at around 05:30 pm, my husband namely, Soibam Sarat Kumar Singh aged about (59) yrs. S/o. (L) S. Birendro Singh @ Babahal of Sorok Atingbi, Khunou, Jiribam, Manipur was forcibly abducted by some unknown persons suspected to be Kuki community from Kamrangkha Khasia near the road crossing of 87th Bn. CRPF Camp, Jairolpokpi Village, Jiribam while he was returning from our farm located at Jairolpokpi, Jiribam on a Pulsar NS 160 bearing registration No. MN06SC-6840 (black in colour). Later on, my husband was found dead with severe injuries on the head at Ngahmunphai village, Tousem Sub-Division, Tamenglong District, Manipur along Mulargao road.

It is, therefore, requested to kindly take necessary action against the unknown culprits.
