Sir,

I have the honour to report that, as normalcy started to return in Manipur, the accused persons, unknown kuki militants and its armed wing are escalating the violent situation of Manipur. Today i.e., 06/06/2024 at around 5.30 pm, one Soibam Saratkumar Singh (59) yrs S/o. (L) Soibam Babahal Singh from Sorok Atingbi Khunou, Jiribam went missing as he was reportedly abducted from Kamrangkha Khasia while returning from his farm at Jairolpokpi, Jiribam by the Kuki militants to reignite the ethnic tension between Meitei and Kuki in the State. Subsequently, the dead body was recovered from Ngahmunphai village, Tousem Sub-Division, Tamenglong District, Manipur along Mulargao road by Jiri Police and security forces during a search operation.

In the facts and circumstances, strict legal action may be taken up against the above-named accused persons; unknown kuki militants, KSO and its armed militant wing by registering a case so as to punish them in accordance with law and to prevent them from committing such offendable acts in future.
