I have the honour to report that, today i.e. 08/06/2024 at about 09.00 pm, some armed miscreants numbering about 20/25 suspected to be Kuki militants entered inside the premises of Leishabithol Police Out Post located at Leishabithol, Jiribam and threatened with dire consequences of all our personnel stating that to leave the Out Post if wanted to live. Immediately, they have fire 2/3 rounds and started burning of our Barrack. In that, one of our barrack (semi pucca with CGI roofing) is completely gutted into fire.

It is, therefore, requested to kindly take necessary action against the culprits.
