I have the honour to report you that on 07-06-2024 at about 2:10 A.M. 1) Lulun Chongloi, aged about 29 years, S/o Daya Chongloi of 40 Leishabithol (Chief of Pangkhot) 2) Helen @ lien, aged about 28 years, S/o of not known of 40 Leishabithol (Pangkhot) and some 15-20 unknown persons of Kuki Militants with arms in their hands came to my farm house situated at Leishabithol Village and set fire in my farm house and destroyed all the infrastructures and plantations including 3 fishery ponds. For the same I have lost about Rupees 90 Lakhs - Rupees 1 Crore approximately of my properties.

I, therefore, request you to take up necessary actions according to law.
