Sir,

I have the honour to state that today i.e., 19/06/2024 at about 9.30 pm, received a reliable information that our Police picket/NAKA check point of Special Mobile Patrol Unit, Jiribam located at Leingangpokpi village, Jiribam along NH-37 was burnt down by some unknown miscreants suspected to be Kuki militants. On receipt of the information, our police team of Special Mobile Patrol Unit, Jiribam along with a team of Fire Service, Jiribam and a team of CDO/Unit, Jiribam rushed to the Police picket. On arrival at the spot, the suspected Kuki militants opened fired at our teams from three different directions of Phaitol village, Tamenglong District, Jiribam in which our teams retaliated. As a result of which, all the vehicles i.e, Special Mobile Patrol Unit, Jiribam, Fire Tender vehicle and vehicle of CDO/Unit, Jiribam were damaged due to hit by bullet. No casualty was reported. However, the structure of the Police picket/NAKA checked point was totally burnt down.

It is, therefore, requested to kindly take up necessary action against the unknown miscreants.
