Sub: - Report.

Sir,

I have the honour to state that today i.e., 19/06/2024 at about 10.20 pm, some unknown persons suspected to be Kuki arms militants attacked by using Sophisticated weapons at Leingangpokpi Police Out Post, Jiribam from the north western side of the Out Post i. e. the Adjoining areas of Tatbung and Phaitol village, Tousem Sub-division, Tamenglong District, Manipur. In that, our teams and the CDO/Unit, Jiribam posted at LPI-OP including 7th IRB personnel deployed at Leingangpokpi areas were also retaliated. The exchange of fire took place for about 15-20 minutes. However, there were no casualties.

It is, therefore, requested to kindly take up necessary action against the unknown miscreants.
