Sir,

I have the honour to report that since 07/05/2023, I along with my family have left my house and village located at Babukhal Khunou, Jiribam, Manipur and taking shelter at Jiribam relief camp due to ongoing ethnic crisis in the state of Manipur. However, I used to visit at village to check my house and other properties during the day time. As usual on 26/06/2024 at around 3.00 pm, I went to my village and found my GCI sheet roofing house and GCI sheet roofing variety shop were burnt down. The act was suspected to be done by unknown miscreants of Kuki community. As a result of which, the house hold properties like furniture items, Utensils, Wooden Almirah, including variety items of the shop were totally gutted. The approximate value of the damaged items is about Rs.7, 00, 000/-(Rupees Seven Lakhs) only. The said unwanted incident might be occurred in between 7th to 10th June, 2024.

I could not be able to submit the report in time as I was unable to visit the said location due to present prevailing ethnic violence in Jiribam District, Manipur.

It is, therefore, requested to kindly take necessary action against the culprits.
