I have the honour to state that on 08/07/2024 at about 3.10 am, when our Police team performing QRT duty at Gularthol Bazar, Jiribam, received a reliable information that one abandoned house located at Leingangpokpi village, Jiribam along NH-37 near our Police picket/NAKA check point of Special Mobile Patrol Unit, Jiribam was set on fire by some unknown miscreants suspected to be Kuki Militants. On receipt of the information, our police team of Special Mobile Patrol Unit, Jiribam along with a team of Fire Service, Jiribam and teams of CDO/Unit, Jiribam rushed to the Police picket. On arrival at the spot and controlled the fire. In the meantime, the suspected Kuki militants opened fire with bomb at our teams from three different directions of Phaitol village, Tamenglong District, Manipur in which our teams retaliated and exchanged of fire. As a result of which, all the vehicles i.e. Special Mobile Patrol Unit, Jiribam, Fire Tender vehicle and vehicles of CDO/Unit, Jiribam were damaged due to hit by bullet. No casualty was reported. However, the said house was partially burnt.




