I have the honour to report that on 08/07/2024 at around 7:45 am, my farm house (semi pucca GCI roofing) having 50 fts in length X 25 fts in breadth value about Rs.6 lacs located at Lalpani south west, Jiribam was burnt down by unknown armed persons suspected to be kuki militants numbering about 10-11. As a result, the following items which were kept inside the farm house were damaged

1) Rubber sheet-714 (seven hundred and fourteen) having 5 quintals worth about Rs. 66, 820/- (Rupees Sixty six thousand eight hundred and twenty) only approximately.

2) Fishing Net (80 fts X 20 fts) having worth about Rs. 16,000/- (Rupees Sixteen thousand) approximately.

3) Silver tray-98 numbers having worth about Rs. 21,500/- (Rupees twenty one thousand and five hundred)

4) 01(One) Plastic table worth about Rs. 700/-

5) 05(five) Plastic Chair worth about Rs.2, 500/-

6) One coil of Electric wire worth about Rs.4, 700/-

7) 10 litre of acid worth about Rs.3200/-

8) Net (happa) -09(nine) bundle worth about Rs. 10,800/-

I have the honour to report that on 08/07/2024 at around 7:45 am, my farm house (semi pucca GCI roofing) having 50 fts in length X 25 fts in breadth value about Rs.6 lacs located at Lalpani south west, Jiribam was burnt down by unknown armed persons suspected to be kuki militants numbering about 10-11. As a result, the following items which were kept inside the farm house were damaged
