

**12. First Information contents:**

Today i.e. 13 /07/2024 at 10:25 pm received an information that on the same day at around 10:15 pm an unruly mob of about 300 to 400 male and female stormed the Sawombung Naka Post. They had physically assaulted one Leitanthem Devid S/o L. Dilip Singh of Kongpal Kshetri Leikai, Imphal East District who is reported to be a party of a road accident that occurred at the area and also obstructed the police party who were performing lawful duty. They destroyed the sentry post installed at Sawombung Naka Post manned by B-33 BSF and civil police.

Hence a Suo-Mottu case under FIR No. 17(7)2024, LLI-PS U/S 191(1)/191(2)/117(2)/324/221/240 BNS has been registered for investigation.
