Today, i.e, 12/06/2024 at 9:20 am received a reliable information that on the same day at about 9:15 am onwards, a group of unknown armed miscreants suspected to be Kuki militants numbering about 50/60 started firing towards Moirangpurel village, Itham village and its adjoining village from Kamu, Bongjang and Saichang villages (erstwhile Kuki inhabited areas) by using sophisticated weapons and explosives substances (bombs) with a view to injure/kill civilian villagers but no casualty is reported.

This blatant act of terrorism committed by the unknown armed Kuki group highlights further escalation of conflict between Meitei and Kuki, causing breach of peaceful existence in the areas, terrorized the general public, felt panicky and fear psychosis, the innocent people have to run here and there for safety of their lives and properties where the general public could not settled peacefully in their own homes and lives are in the stake which tantamount punishment.

Hence, a suo motu case under FIR No.20(06)2024,TBL-DAM-PS, u/s: 400/307/447 IPC, 25(1-C) Arms Act & 3-Expl. Subs. Act has been registered for investigation.
