Subject: Report.

Sir,

I have the honour to report that today i.e. the 26th July, 2024 received a reliable information from 4 AR corroborated with our own intelligence about the presence of some anti social elements in and around Chingarel Tejpur Imphal East District. Based on the said information, teams of CDO Imphal East Unit led by myself comprising of ASI. Kh. Victor Singh of CDO/IE, ASI Johnny Elangbam of CDO/IE Unit and Hav. No. 072007028 Kiran Heisnamba of 7th MR now attached with CDO/IE under the command of Inspt. Kh. Henery Singh, Officer-in-Charge, Commando Imphal East Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP (Ops) Imphal East District and under the overall guidance of Shri. K. Meghachandra Singh MPS, Superintendent of Police, Imphal East District conducted a Counter Insurgency operation at Chingarel Tejpur and its surrounding area of Imphal East District.

As a part of the operation, teams of CDO/IE Unit conducted random frisking and checking to the suspected passersby. During the course of the frisking and checking, one passenger vehicle (Tata Magic), white in colour, plying between Imphal to Lamlai coming from southern side was stopped for checking and verification of the passengers. In that, one passenger suddenly jumped down from the inside the vehicle (Tata Magic) and tried to run away from our CDO personnel. Immediately, our CDO personnel rounded up the suspected person from all sides and put under control. On verification, the suspected person identified himself as one; **Shrimayum Rishikesh Sharma @ Loijing, (aged about 21 years) S/o Sh. Kanta Sharma of Nilakuthi Awang Leikai, Imphal East District.** On further verification, the detainee stated that he is an active cadre of the outfit KYKL who joined through one Mr. Khambaton of KYKL in the month of May, 2024 and got his basic military training for 30 days under the command of one Mr. Japan of KYKL. So, the detainee was arrested from the spot i.e. Chingarel Tejpur, Imphal East District at 4:07 pm by observing due formalities.

On further verification, the arrestee stated that he kept concealed one Lethod gun and some shells at Thubi Chingkhong, Nongpok Sanjenbam, Imphal East District which was handed over to him by one Mr. Bhakta of KYKL. Immediately, our team along with the arrestee rushed to the said place and on the pointing and instance of the arrestee, our CDO team recovered and seized; **(i) One Lethod Gun, (ii) 10 (ten) nos. of Lethod Shell, (ii) One smoke shell and (iii) One Lethod Shell Holder/jacket** from Thubi Chingkhong, Nongpok Sanjenbam, Imphal East District at 5:39 p.m. by observing due formalities.

Therefore, the arrested person along with seized item is being handed over to you for taking up further legal procedures against him.
