LODGING OF FIR AGAINST MEIRAPAIBIS, UNLF (MPA) AND ARAMBAI TENGGOL

- Indian Army columns are deployed in General Area Itham, Moirangpurel, Tumukhong, Maphou, Monghlam Base, Kamu and Malkon in Aid to Civil Authorities. Based on specific inputs, on 12 Jun 2024 at around 1030hrs, Indian Army Column in Itham intercepted movement of an Arambai Tenggol (Unit AT-54) vehicle, which was moving towards Moirangpurel and further towards Maphitial Ridge, allegedly for launching attack. The Indian Army Column made fervent attempts to stop and inspect the vehicle, however, they were restrained by the presence of Meirapaibis sitting inside the vehicle who had allegedly hid the illegal weapons inside their clothes. Within no time, the unlawful riotous mob of around 350-400 Meirapaibis congregated at location and intentionally obstructed the Army column from discharging their official duty by blocking the movement of column as well as by shielding the Arambai Tenggol Vehicle. Meirapaibis, thus, deliberately facilitated the escape of Arambai Tenggol vehicle from the location along with
- In addition, at 1230hrs, the same group of Meirapaibis illegally surrounded Indian Army 2. Column at Island Village and unlawfully restrained their free movement so as to impede them from discharging their official duty as well as raised slogans against the Army to go back.
- In the meanwhile, at 1345hrs, nine alleged UNLF (MPA) vehicles along with weapons, 3. under leadership of one Mr Pajingba (Tiger), allegedly from Brigade 1, reached Tumukhong Junction with the intent to move towards Maphitial Ridge/ Kuki Villages for the purpose of allegedly launching an attack towards Maphitial Ridge. They were stopped by the Indian Army Column to prevent their further movement towards Maphitial Ridge/ Kuki Villages. However, during this instance, the cadres started a heated argument with military check post Commander at Tumukhong Junction and forced their way through towards the Hill area by cocking the weapons and pointing them towards the Indian Army Column with clear and deliberate intent to threaten the column.
- UNLF (MPA) were again stopped by Indian Army column at the foothills of Maphitial 4. Ridge and fervent attempts were made to move them back from Tumukhong village. Meirapaibis from Tumukhong Village again tried to obstruct the movement of Indian Army inside Tumukhong village and further provided human shield to protect UNLF. The UNLF moved out of the Tumukhong Village, however, they again started a heated argument at Tumukhong Junction and also pointed weapons at Indian Army column, and finally moved back.

- In view the above, FIR against unknown/ unidentified eirapaibis (Photographs attached) 5. and other riote in General Area Itham, Moirangpurel and Lumukhong may be lodged for the following offences:
 - Obstructing Public Servants from discharge of their official duty in suppressing (a) and dispersing unlawful assembly contrary to the aforementioned provision incl Sec 353. 503, 504, 505 and 506 of the IPC.
 - Obstructing the Public Servants in apprehending the armed miscreants and (b) unlawfully resisting their arrest contrary to Sec 201, 223, 224, and 225 of the IPC.
 - Assisting/ aiding escape of the armed miscreants from the lawful custody of Indian Army while performing bonafide military duty in Aid to Civil Authorities, contrary to Sec 201, 223, 224 and 225 of the IPC.
 - (d) Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to Sec 34, 120, 350, 353 and 332 of the IPC.
- 6. FIR against one Mr Pajingba and other members of UNLF (MPA) (Photographs attached) may be lodged for the following offences:
 - Possession of illegal arms and ammunitions contrary to S 25(1C) and S 27 of Arms Act, 1959.
 - Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to Sec 34, 120, 350, 353 and 332 of the IPC.
 - Rioting while being armed with a deadly weapon or with anything which if used as a weapon is likely to cause death contrary to Sec 146, 147,148 and 149 of the IPC.
 - Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to the aforementioned provision including Sec 353, 503, 504 and 506 of the IPC.
- FIR against Arambai Tenggol (Unit AT-54) may be lodged for the following offences: 7.
 - Obstructing Public Servants from discharge of their official duty in suppressing (a) and dispersing unlawful assembly contrary to the aforementioned provision incl Sec 353, 503, 504, 505 and 506 of the IPC.
 - Criminal Intimidation, Assault and Criminal Force against Public Servants discharging public duty in Aid to Civil Authorities contrary to Sec 34, 120, 350, 353 and 332 of the IPC.
