Subject :- Report on Looting, Burning, Vandalism of household items/assets . Sir,

With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Lalkhomang Touthang aged about 32 years 11/0 Nengsiemkim Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent resident of Twichin village, P.O & P.S trans. Kangpokpi District, Manipur.
- 2. That at about 7:00 pm on the 28th of may 2023, our village were attack by Terror group suspected to be members of the Arambai Tengol, Meetei Leepun and UNLF along with Meitei Mob with an intent to Murder and looted, Vandalized and burn down our house with state forces remaining as a mute spectator to the unfolding horrendous events.
- That, the above name terror groups came with deadly sophisticated weapon like Ak-Rifle, SLR, Bomb, Machate/Sword, iron rods, with an intent to murder.
- 4. That, the said terror groups were shouting anti-tribal(kuki) slogans while attacking our village, like"KUKI Hatlo" etc meaning"kill the kukis", "kill the tribal".
- 5. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.9007000/- (Rupees ninty Lakhs seven Thousand) only.
- 6. Fortunately, me and my family managed to escaped from the said terror groups and took shelter at Ebenezer relief camp Tuibong, Churachandpur Manipur.
- 6. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Ebenezer Relief camp Tuibong Churachandpur .And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
