I have the honour to report that today i.e. 19th June, 2024 at about 12:10 p.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outfit KCP at Heingang area of Imphal East District. Acting on the said input, teams of CDO Imphal East Unit led by myself under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. K. Meghachandra Singh, MPS SP/IE District conducted a random frisking and checking to the suspected passersby at Ahallup Thongkhong, Imphal East District.

In that, the combined team detained one suspected person who came in a scooter for verification. On checking the detainee body, one sling bag containing a sum of Rs. 1, 15, 000/- (one lakh fifteen thousand rupees), two nos. of mobile phones and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one Kharibam Surchandra Singh @ Telheiba, aged about 53 years, S/o Kh. Ibopishak Singh of Langthabal Kunja Awang Leikai, Singjamei PS, Imphal West-District an active member of the outfit KCP (Noyon) who joined the said organisation in the month of June, 2023 through one Mr. Ibungo of KCP (Noyon) and presently working under the command of the said Mr. Ibungo of KCP(Noyon). On further verification, the detainee stated that on the advice of the said Mr. Ibungo of KCP (Noyon) he had made monetary demand to the various govt. offices and schools located at Imphal area and collected a huge amount of money for raising their party fund. He further stated that, the above recovered money i.e. Rs. 1, 15, 000/- (one lakh fifteen thousand rupees) was extorted today from various govt. schools officials/staff of Imphal East District on the advice of the said Mr. Ibungo of KCP (Noyon) and he is on his way back to home after collecting the extorted money.

So, the detainee was arrested from the spot i.e. Ahallup Thongkhong near Community Hall, Imphal East at 1:30 p.m. and seized; (i) One scooter (Hero Pleasure), white in colour, bearing regd. no. NL-07J/7184 bearing Chassis no. MBLJF16EDCGE20953 & Engine no. JF16EBCGE20661, (ii) one mobile phone (Redmi Note 11) bearing IMEI no. 865212054801175 & 865212054801183 along with one Jio SIM card bearing no. 8991160990023587991U (iii) one mobile phone (Nokia) bearing IMEI no. 350138383806407 along with one Airtel SIM card bearing no. 8991160990023204466U and (iv) one wallet containing a sum of Rs. 120/- (one hundred twenty rupees), one AADHAR card and one vehicle regd. certificate (photo copy) and (v) One sling bag, black in colour, containing a sum of Rs. 1, 15, 000/- (one lakh fifteen thousand) rupees from his possession at the spot i.e. Ahallup Thongkhong near Community Hall, Imphal-

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal procedures against him.
