Sir,

I am writing this letter to inform you the sequence of incidents that happened on 17/06/2024 at Manipur Central Jail (MCJ) Sajiwa, Manipur. That

- a) SP Sajiwa informed through WhatsApp call at around 2.45 pm, that commotion took place inside the Foreigner Detention Centre, Sajiwa and immediate action required.
- b) As such, I along with Manipur Central Jail, Sajiwa and Foreign Detention Centre team rushed to the FDC and handled the situation.
- c) Commotion was between SP Sajiwa team and some foreigner Detainers.
- d) At around 3:30pm, the Foreigner Party started pelting stone/brick towards SP team.
- e) SP & team were surrounded by the Foreign Detainers which might be around 118 personnel.
- f) In order to rescue the SP & teams, 39 rounds were blank fire of and used stun shells to disperse the FDC personnel. As such, SP & team were timely rescued.


