Description of the Accident : Mashuchan Ragui was riding his Activa (Registration No. MN01AB6737) on the left side of the road towards Khuman Lampak to pick up someone arriving from Ukhrul. While riding , another Activa (Registration No. MN06SH2278) made a sudden turn to cross the road in front of him. As my brother was following closely behind, he was unable to avoid a collision.

Injuries sustained (if any) :- Mashuchan Ragui is badly injured, having a cracked skull and other injuries.

Damage to property :- Only scratches on the bike.

I request you to kindly registered an FIR regarding this accident and investigate the matter further, I am available to cooperate fully with the investigation and provide any additional information that may be required. If there were any witnesses to the accident, I will try my best to gather their name and contact information.
