I have the honour to report that today i.e. the 21<sup>st</sup> July, 2024 teams of CDO Imphal-East Unit under the command of Inspt. Kh. Henery Singh of CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and under the overall guidance of Shri. K. Meghachandra Singh MPS, SP/IE District conducted searched operation, CI Ops, frisking and checking at various parts/areas of Imphal East District for the whole day starting from the dawn, in connection with the yesterday i.e. 20/07/2024, killing/shooting incident of one person at Takhel, area by some unknown arms miscreants.

As a part of the said operations, teams of CDO/IE Unit conducted a random frisking and checking to the suspected passersby at Pangei Bazar near auto-rickshaw parking, Imphal East district at about 6:00 p.m. In that, one suspected persons was detained for spot verification and checking. On verification conducted by the CDO personnel the detainee identified himself as one, **Khoirom Ranjit Meitei @ Poirai @ Rocky (44 years) S/o (Late) Kh. Ningthourel Meitei of Yairipok Laimanai**, Imphal-East District. One checking his body two nos. of mobile phones were found from his possessions. During the course of further verification, a large nos. of mob is being approached towards our police team and enquired why the detainee is being detained. Since the nature and expression of the detainee is very disturbed and perturbed, the question of suspicion of the detainee is highly arise. Considering the situation and importance of further verification, our CDO team further detained the man and bring the detainee and his belongings at the office of CDO/IE Unit at Porompat, Imphal East District for further thorough verification. On reaching the office of CDO/IE Unit i.e. Porompat, Imphal East, further verification were conducted.

In that, it came to learnt that the detainee is presently an active member of the outfit KCP (Lamyamba Khuman). On further verification, conducted by our team, the detainee stated that he was a former member of the outfit KYKL joined in the year 2006 and worked under the command of one s/s - Sergeant Mr. Laiba of KYKL. The detainee further stated that he was arrested in the same year by security forces and jailed for seven year at Tihar Jail, Delhi. After released from Tihar Jail, Delhi he joined that outfit KCP (Lamyamba Khuman) in the month of April, 2024 through the said s/s - Chairman Mr. Lamyamba Khuman @ Mangoljao of KCP (Lamyamba Khuman) group and presently working under his command. On the advice of the said Mr. Lamyamba Khumna he had re-organised and regrouped their outfit cadres/members. He further stated that he had recruited about new sixty cadres of their organisation from the various parts of the state. He also stated that he is directly involved in extortion of money from the general public, private firms, govt. offices etc. for raising their party funds and arranging/buying weapons for their newly recruited members.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Porompat, Office of CDO/IE Unit at 10:51 p.m. by observing due formalities. One mobile phone (Redmi Note 11) bearing IMEI no. 86596006046861700 & 86596006046861725 along with two Airtel SIM cards bearing no. 8991160990018113121U & 8991160990021188509U and (ii) One mobile phone (Samsung Galaxy F14 5G) bearing IMEI no. 356412387754226/01 & 356412387754225/01 along with one Airtel card having no. 8798130319 (as disclosed by the arrestee) and one Jio SIM card bearing no. 89918650400127127191 from his possession at 10:52 p.m. by observing due formalities.

Thereafter, the arrested person along with seized item is being handed over to you for taking up further legal procedures against him.
