Yaima Meitei of Langol Lai Manai, IW lodged a written report to OC/HNG-PS stating that 13/08/2024 at around 11:30 am, he along with his wife namely Khaidem Sonia Devi aged about 26 yrs were on the way to her parented home located at Maharabi, IW ( Imphal toward Sekmai) along NH-2 by riding his Honda Activa bearing registration No. MN01C-8992 red in colour, when they reached at Khabam Chumbreithong near NRL Oil Pump one unknow vehicle hit his Honda Activa from behind and they got unconscious at the spot and the said unknown vehicle fled away from the spot, and he got badly injuries on his body and his wife also got injury on her hip & head and they are evacuated to Hospital for medical treatment. Later it is learnt that the said vehicle was one Tata DI bearing registration No. MN07C-3122 white in colour. He could not report the matter to the police well in time as he along with his wife were busy in medical treatment. Hence the case.
