Today i.e. 08/06/2024 at 7.45 am. received a reliable information that on the same day at about 3.30 am, 20/30 arms groups suspected to be kuki militant attacked with bombs and gun firing to Durgapur. Lamtaikhunou Meitei village. In that about 52 (Fifty two) houses including 3(three) shops were set ablazed. As a result of which, some of the houses were totally burnt down and valuable household articles were also

burnt/damaged in other some houses.

Immediately police and AR personnel rushed there and retaliated. However the unknown arms Kuki militant escaped/ towards fled away.

Hence a Suo-Motto case under FIR No.07(06)2024 BBK-PS u/s. 400/436/427/451/34 IPC & 25(1-C) A. Act. & 3 Explosive sub. Act has been registered for investigation.
