Sir,

With due regards, I beg to state that today on 23/07/2024 at about 4.00 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Leirongthel Pitra near Water Tank for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:20 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) SMG carbine along with magazine bearing registration No. 18251225, (2) 1(one) 9mm Pistol along with magazine bearing registration No. P-7342, (3) 1(one) .32 Pistol along with magazine bearing registration No. P-1428, (4) 1(one) 12 Bore Bolt action Shotgun, (5) 4(four) nos. of live 36 Hand Grenade with arming ring, (6) 3(three) nos. of live Mark-III A2 grenade, (7) 14(fourteen) nos. of 7.62mm live round, (8) 24(twenty-four) nos. of 5.56 mm live round, (9) 2(two) nos. of 12 bore cartridge, (10) 5(five) nos. of 9mm live round, (11) 2(two) nos. of .32 mm live round, (12) 2(two) nos. of tube launching, (13) 1(one) no. of Baofeng radio set and (14) 4(four) nos. of detonator from the spot at 5:16 am. The massive searched Operation was conducted from 4:20 am to 6:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
