With due regards and humble submission I, the undersigned have the honour to report the following facts for your kind consideration and further necessary action,

That on, 26/07/2024 at @ 06:45 pm, when I returned from Nongpok Sekmai after purchased some hardware items from Shikhong Sekmai Bazar. On reaching at Aripat area some unknown persons numbering around 2/3 persons holding with knives and wooden logs have intercepted and force to snatch my vehicle. On their strange gesture, I forcibly escaped from the spot and drive toward Yairipok road but they also follow me to overtake on one Alto Maruti Car suspected to be Silver in colour but its registration no. could not be identified as it was a dusk. But the unknown persons were stopped and retreated when I reached at Pechi village.

From the above fact and circumstances, I therefore requested kindly to arrest the accused persons and punish according to the law.
