Subject : Report.

Sir,

With due regards, I beg to state that today on 05/08/2024 at about 03:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Leirongthel Pitra Lok Macha for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:10 am. On searching and found the undernoted articles i.e. (1) 2 (two) Nos. of 9 mm SMG with Magazine bearing Regd. No. 18250791 and 15395261, (2) 2 (two) Nos. of 9 mm Pistol bearing Regd. No. B-4558 and L-4931, (3) 1 (one) No. of .32" Pistol bearing Regd. No. C-2092, (4) 2 (two) Nos. of .303 Rifle (country made), (5) 1 (one) No. of 12 Bore Single Barrel Gun, (6) 6 (six) Nos. of 36 Live Hand Grenade (which can be use as explosive), (7) 3 (three) Nos. of Live MK-III A2 Grenade, (8) 6 (six) Nos. of Live Tear Smoke Shell, (9) 5 (five) Nos. of 12 Bore Live Cartridges, (10) 15 (fifteen) Nos. of Live 9 mm Ball rounds, (11) 40 (forty) Nos. of 7.62 X 39 mm rounds, (12) 44 (forty four) Nos. of 7.62 mm Live rounds (13) 3 (three) Nos. of Live .32" Ball rounds, (14) 12 (twelve) Nos. of Live 5.56 mm INSAS Ball Rounds, (15) 1 (one) Tube Launcher, (16) 2 (two) Nos. of 36 Hand Grenade Detonator (17) 2 (two) Nos. of MK-III A2 Grenade Detonator and (18) 1(one) Hand Set marked as Baofeng from the spot and seized at 05:00 a.m. The massive searched Operation was conducted from 4:10 am to 6:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
