Sir,

With due respect, I have the honour to report that today i.e. 18/07/2024, @ 2.30 am on received a reliable information from 4 AR corroborated with our own intelligence that activities of some armed miscreants were seen in Teraphai/Tuisenphai foothills (East to Takhel village) under Lamlai PS. Accordingly, a joint team of CDO IE led by Inspt. Kh Henery Singh OC- CDO, Imphal East and OC- Lamlai PS along with CDO teams of Imphal East under the command of Shri Kh. Herojit Singh, MPS, Addl. SP (Ops) Imphal East immediately organised and rushed to the area and conducted search operation from 4:00 am onwards. During the search operation recovered 1) 1(one) 303 Rifle having Butt No. 143 with magazine and 10 nos. of live rounds, 2) 01(One) Carbine regd. No. AD0062, SAF 1978 with magazine having 5 live rounds covered by 2 white gunny bags and 3) 02 (Two) nos. of 36 Hand grenade, 4) 01(One) WP Green colour no. 80 Mark I Grenade in a polythene and 5) 1(One) Pistol having wooden hand grip without Magazine Regd. No. Nil 6) 47 (Fortyseven) Nos. of 7.62 mm empty cartridge and 7) 2 (Two) nos. of 5.56 mm empty cartridge in another black polythene covered by a gunny bag were found abandoned under the bushy area of Teraphai/Tuisenphai hillock about 150 metres at the Eastern side from the Trijunction and the same were seized at 5.50 am by observing the legal formalities and the operation was closed at 7.00 am of the same day.

It is therefore submitted for taking further necessary legal action.
