Sir,

With due regards, I, the undersigned have the honour to state that today i.e. 06/08/2024 at about 04:15 am conducted Cordon and Search Operation (CASO) by a combined team of District Police, Thoubal led by Shri N. Sadananda Singh Dy SP CDO/TBL assisted by Inspt. K. Nitaranjan Singh, OC/CDO Thoubal, a team of NSK-PS, 4 teams of CDO/TBL and a column of 4 AR COB Somrei under the command of Shri H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr.SP/TBL at Mayai Keithel and Irong villages. During the course of house to house search operation at Mayai Keithel village about 67 (sixty-seven) Nos. of houses were searched and verified 134 (One hundred thirty-four) Nos. of individuals whereas no arrest were made.

On further course of search operation at Irong village near car wash shed found the undernoted articles suspected to be kept and hidden by some unknown miscreants i.e. (1) 01 (one) No. of INSAS LMG bearing registration No. 18202296, (2) 01 (one) No. of INSAS Rifle bearing registration No. 16841618, (3) 01 (one) No. of AK-56 Rifle bearing registration No. 1917571 along with magazine, (4) 01 (one) No. of 9 mm Pistol (Country-made) along with magazine marked as USA, (5) 01 (one) No. of .32mm Pistol along with magazine bearing registration No. 1027, (6) 03 (three) Nos. of INSAS LMG magazine, (7) 02 (two) of INSAS magazine, (8) 90 (ninety) Nos. of 5.56 mm ammunitions, (9) 15 (fifteen) Nos. of 7.62 x 39 mm ammunitions, (10) 04 (four) Nos. of 9 mm ammunitions, (11) 04 (four) Nos. of .32mm ammunitions and (12) 01 (one) No. of Baofeng Hand Held Set have been seized from the foothill of Irong village near Car Wash Shed at 05:10 am. The massive search Operation was conducted from 04:15 am and continued till 07:10 am of the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
